SECTION 4: FIRST AID MEASURES

General Advice: Consult a physician. Show this SDS. Move out of dangerous area.
If inhaled: Allow the victim to rest in a well-ventilated area. Seek immediate medical attention.
In case of skin contact: After contact with skin, wash immediately with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. Examine the lips and mouth to ascertain whether the tissues are damaged, a possible indication that the toxic material was ingested; the absence of such signs, however, is not conclusive. Loosen tight clothing such as a collar, tie, belt or waistband. If the victim is not breathing, perform mouth-to-mouth resuscitation. Seek immediate medical attention.
