SECTION 4: FIRST AID MEASURES

General Advice: Consult a physician. Show this SDS. Move out of dangerous area.
If inhaled: Allow the victim to rest in a well-ventilated area. Seek immediate medical attention.
In case of skin contact: After contact with skin, wash immediately with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. Be particularly careful to clean folds, crevices, creases and groin. Cold water may be used. Cover the irritated skin with an emollient. If irritation persists, seek medical attention. Wash contaminated clothing before reusing.
In case of eye contact: Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open. Cold water may be used. Do not use an eye ointment. Seek medical attention.
If swallowed: Do not induce vomiting. Rinse mouth with water. Examine the lips and mouth to ascertain whether the tissues are damaged, a possible indication that the toxic material was ingested; the absence of such signs, however, is not conclusive. Loosen tight clothing such as a collar, tie, belt or waistband. If the victim is not breathing, perform mouth-to-mouth resuscitation. Seek immediate medical attention.

SECTION 5: FIRE FIGHTING MEASURES

Suitable extinguishing media: SMALL FIRE: Use DRY chemical powder. LARGE FIRE: Use water spray, fog or foam. Do not use water jet.

SECTION 7: HANDLING AND STORAGE

Precautions for safe handling: Keep away from heat. Keep away from sources of ignition. Avoid formation of dust and aerosols. Provide appropriate exhaust ventilation where dust is formed. Ground all equipment containing material. Do not ingest. Do not breathe dust. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes.

Conditions for safe storage: Keep container tightly closed in a dry and well ventilated place. Ground all equipment containing material. Recommended long term storage temperature -20°C.

Hand protection: Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.

Eye protection: Wear safety glasses with side-shields conforming to EN166 Use equipment for eye protection tested and approved under appropriate government standards such as NIOSH (US) or EN166 (EU).

Skin and body protection: Wear appropriate gloves and clothing to prevent skin exposure.
