SECTION 4: FIRST AID MEASURES

General Advice: Consult a physician. Show this SDS. Move out of dangerous area.
If inhaled: Allow the victim to rest in a well-ventilated area. Seek immediate medical attention.

Loosen tight clothing such as a collar, tie, belt or waistband. If the victim is not breathing, perform mouth-to-mouth resuscitation. Seek immediate medical attention.
